

SUBURBAN SHOWDOWN 2008 - ONYX ENROLLMENT AGREEMENT & RELEASE

In consideration of my enrollment and participation in a Suburban Sports Group program, I hereby release and discharge Suburban Sports Group and the Onyx-Rochester Ice Arena (hereinafter referred to as "SSD") together with their agents, employees, officers, owners, sponsors, volunteers and all other participants forward on behalf of myself, my children, my parents, my heirs and assigns as follows:

1. I acknowledge that the sport of hockey involves known and unknown risks which could result in physical or emotional injury, paralysis, death, or damage to participants, to myself, to property or to third parties and that such risks simply cannot be eliminated. To that end, I further acknowledge that SSD is not responsible for a participant's fitness, abilities or the equipment being used.
2. I acknowledge and agree to accept and assume any and all of the risks attendant to this activity. My participation in this activity is purely voluntary and I elect to participate notwithstanding the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless SSD from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity or my use of SSD equipment or facilities whether "on" or "off" the ice and, including any claims which allege negligent acts or omissions on the part of SSD.
4. In the event SSD, or anyone acting on their behalf is required to incur attorney's fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance coverage for any injury or damage I may cause or suffer while participating, and I agree to bear any and all costs of such injury or damage. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, and I am willing to assume all risks and costs that may result, directly or indirectly, from any such condition.
6. I acknowledge that during the course of participation, SSD may take photographs, audio recordings and/or video recordings of me. I hereby grant SSD permission to use any and all such photographs or audio or video recordings of me for advertising, promotional or educational purposes. Such use may include publication in programs, advertising, posters, flyers, radio, television or other methods, and may be seen or heard by large numbers of individuals, including potential customers of Suburban. Participant waives all rights to any financial remuneration of any such use.

By signing this Document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I have waived my rights to maintain a lawsuit against SSD.

I have had sufficient opportunity to read this entire document. I understand it and I agree to be bound by its terms.

In consideration of _____ being permitted by SSD to enroll and participate in its activities and to use its equipment and facilities, I have acknowledged and executed the foregoing Enrollment Agreement and Release. I further agree to indemnify and hold harmless SSD from any and all claims which might be brought by, or on behalf of Minor, and which are in any way connected with such enrollment or participation by Minor.

• DIVISIONS OFFERED

Mite 2000 & 2001
Squirt 1998 & 1999
Pee Wee 1996 & 1997
Bantam 1994 & 1995

• FOURTEEN SKATES!

All players will participate in one evaluation skate:

- Pee Wee - Mon. March 31st (Wed. April 2nd, if necessary)
- Bantam - Mon. March 31st (Wed. April 2nd, if necessary)
- Mite - Tues. April 1st (Wed. April 2nd, if necessary)
- Squirt - Tues. April 1st (Wed. April 2nd, if necessary)

Each team will then be provided with a schedule that has two practices and 11 league games (11-minute stop-time periods/50 minute curfewed games) that will be played at Onyx-Rochester Ice Arena. All teams will make the playoffs. Playoffs will be a single-loss elimination format. There will be no games against teams from the Team Registration League.

*If there are not enough players to form a league at the Onyx, the league may be combined with Suburban Ice - Macomb.

• GREAT SCHEDULE!

Every effort will be made to develop a consistent schedule that will end in mid-June. Skates will take place either Monday, Thursday, Saturday and/or Sunday. No games will be scheduled May 11 (Mother's Day) or May 24-26 (Memorial Day weekend).

• PLAY WITH FRIENDS!

Although players will be evaluated and assigned to teams to ensure a competitive level within each division, we will try to honor requests for friends to play together on the same team whenever possible. Please indicate on your registration form if you would like to play on the same team as a friend. NOTE: All players requesting to play together MUST attend the evaluation skate.

• NO HIDDEN FEES!

You will NOT be required to pay extra for referee fees, ice resurfacing or playoff games.

• UNIFORMS!

Players will be provided with a team jersey and socks prior to the first game.

• AWARDS!

Individual playoff championship and finalist awards will be provided.

• HOCKEY SCHOOL DISCOUNT!

All players rostered on Suburban Showdown teams will be eligible for a 10% discount toward Suburban Hockey Schools during the summer of 2008 if they register by April 30!

• REGISTRATION

Full payment of \$235 is due with registration. Make checks payable to "Suburban Hockey." No refunds will be offered after Monday, March 31. Prior to that time, there will be a \$25 fee on all cancellations. A \$40 fee will be assessed for all NSF checks.

• USA HOCKEY REGISTRATION

All players must be registered with USA Hockey before their first game. Players are responsible to attach a copy of their USA Hockey IMR (Individual Membership Registration) to the registration form. If you do not have a copy of this form or card, a copy of your team's fall roster will be sufficient. Players who are not currently registered with USA Hockey or who are unable to provide proof of registration/insurance need to register online at www.usahockeyregistration.com and pay the \$35 fee required by USA Hockey.

• DUAL ROSTERING

Players may be rostered on two teams, provided that the teams are not in the same division (i.e. a player on a team in the Individual Registration League may also be rostered on a team in the Team Registration League).

• COACHING EDUCATION PROGRAM

Volunteer coaches will coach the teams (three per team). Online resources available at www.suburbanhockey.com and then click on the Coaches Club Icon, resources include:

- Coaching manual with such topics as bench management, motivational techniques, practice planning, etc.
- Practice plans and drills

To volunteer as a coach for the Suburban Showdown, please complete the individual player registration form. Be sure to indicate that you are volunteering to coach, the age division you would like to coach, whether you are registered with USA Hockey, and the player's name (if you have a player in that age group).

Coaches will be required to attend the evaluation skates to assist in the evaluation process. Once teams are assigned, coaches will be notified of their team rosters, practice times and game schedules.
